

# Consent form of application for examination

## Personal privacy information policy

### Article 1 Acquisition and retention of personal information

The method of acquiring our personal information is as follows.

- 1.Obtaining direct consent from the person
- 2.Oral acquisition of personal information by the Examination Dept.
- 3.Acquisition from providers / shared users

We will retain personal information obtained from shared users at the time of examination and contract conclusion.

In addition, if we do not accept the application or the lease contract is canceled We will retain the personal information even after the applicant moves out.

### Article 2 About the purpose of use of personal information

We will use the personal information obtained from customers within the following purposes.

- 1.For operations related to the examination, conclusion, performance, and claim of entrustment fees for guarantee consignment contracts and guarantee contracts.
- 2.For management and exercise of guarantee contracts and claims related to guarantee contracts.
- 3.For storage agency business such as rent and guarantee fee and rent management business

- 6.To provide to a third party (including shared use) to achieve the purposes 1 to 5 above.

### Article 3 Shared use of personal information and information providers

We may jointly use and provide the acquired personal information for the purpose of use in Article 2.

The range of shared use is as follows.

Shared use destinations: lessor, real estate agent, guarantee company, storage agency and, if newly joined in the future, rent debt guarantee information handling agency, credit information agency

Information sources: Government offices, lawyers \*, financial institutions \*, storage agents \*, lessors, real estate agents \*, guarantors (including prospective guarantors), residents, emergency contactor, family, etc. Work relationship of the person  
Personal information shared and provided is the content of personal information acquired pursuant to Article 1.

\* The recipient of the seal may have a contract regarding the handling of personal information.

### Article 4 About entrustment of personal information

We may outsource the handling of personal information to a third party. When outsourcing, we will manage the outsourcee appropriately.

### Article 5 Consent for provision of personal information, etc.
